
Officer McCaffrey responded to _____ in reference to an aggravated assault/ attempted arson. On 06/23/2010 at approx 1430 hrs, I responded to this location in reference to a follow up investigation. Daniel Huggins and his girlfriend Dawn Pelosi (11/28/1962) care for their children at this location. They have a son together, _____ (09/05/1998) and Daniel has another son, _____ (dob 07/23/1992) who also resides here.

Upon arrival I observed the home did not have electricity. Boynton Beach Code Compliance Officer Skip Lewis was on scene and declared the home was condemned due to the living conditions.

While walking through the home I observed various items cluttering the residence. There were items such as recycling bins, electric lawn tools, a motorcycle, and various propane grills inside which could pose as potential safety hazards. There were feces on bathroom floor and all over the bathroom toilet. The toilet was not flushed and inoperable. The toilet was located in the hallway near the living room. Neither bathroom showed any sign of toilet paper. There were blood droplets on the floor throughout the residence. The kitchen sink was filled with dirty dishes. Cigarette butts were located in miscellaneous locations, not in ash trays throughout the residence. The refrigerator was empty and covered in mold. There were coolers with food in the kitchen area but the food products were no longer cold. The north exterior portion of the residence had a distinct odor of human feces.

Dawn is the sole provider for the family. She advised that she has to support the family on her own working 40 hours a week at Duffy's Sports Bar because Daniel refuses to get a job. Dawn stated Daniel's unemployment and extended benefits ran out. The family does not receive food stamps. Daniel is the caretaker for the children during the day while she is away at work. Daniel has no known medical conditions. Dawn advised the electricity to the residence has been turned off for one and a half months, but it could have been longer. Dawn stated the family camps inside the home. They have electric fans, battery powered lights, grills and ice. Dawn stated that she did not turn on the electricity sooner because she wanted Daniel to obtain employment and turn it on. Dawn advised the water in the house works but toilet in the bathroom was not working. Dawn stated they have the parts to fix the toilet, it just needs to be done.

Due to the above, I have determined that Daniel Huggins has failed to provide _____ with the care or services necessary to maintain their physical and mental health that a prudent person would consider necessary for the wellbeing of the child. Daniel is charged with Child Neglect without Harm pursuant to FSS 827.03(3)(c).
