






(Specifically include facts constituting cause for arrest.)</p> <p>On the above date and time, _____ came to BBPD with her children to report that sexual crimes had been committed on her three juveniles daughters as well as her juvenile niece. Their names are: _____ (12/22/1995), _____ (11/01/2001), _____ (09/12/1998), and _____ (06/22/1987). A preliminary interview with each of the children revealed that sexual acts had occurred to each of them over the past few years, but not currently as the suspect (Kengi Merritt) had moved to Orlando over two years ago. The interview also determined that these sexual acts occurred at different locations throughout Boynton Beach, specifically _____ in Boynton Beach. Based on this information, DCF was notified and began their investigation. On this same date, I showed all children and _____ a Florida Driver's license photo of Kengi Merritt (B/M DOB: 12/01/1980) and they positively identified him as the same person that had committed these acts.</p> <p>On 07/23/2010, I attended a CPT interview for _____ spoke openly about several incidents one specifically while she was attending _____, where she was held down by force and sexually penetrated by Merritt. After being interviewed, _____ completed a physical examination that found vaginal scarring from tearing. It should be noted that _____ stated that she has had no other sexual relationships. Immediately following CPT, I conducted a controlled consensual telephone call between _____ and Kengi Merritt. Merritt was confronted on several occasions with his sexual actions toward _____ and the other girls and he repeatedly said that he did not want to talk about it over the phone and specifically said that he didn't want to incriminate himself and go to jail. Several hours later, I conducted another controlled telephone call between _____ and Merritt. _____ specifically told Merritt that if he were to come and live with her family that he had to promise that he would not do "nasty" things to them again. Merritt never denied the "nasty things" and actually promised that nothing would happen and that he did not want them to be uncomfortable around him (Merritt). Also in this telephone call, _____ reminded Merritt of a time that she and Merritt had sex and questions if it would hurt if she had sex with her boyfriend. Merritt never denied the sexual intercourse comment and even comments that it probably would hurt.</p> <p>On 07/24/2010, I conducted another consensual recorded telephone call between _____ and Merritt. _____ confronted Merritt with the sexual allegations made by her daughters against Merritt.</p>

(Specifically include facts constituting cause for arrest.)</p> <p>At first Merritt denied that he had ever done anything sexual with _____ daughters or niece, but then recanted and began to make statements that _____ would come on to him and once wore a red dress around him and had shown off her private area..</p> <p>Merritt also stated that on numerous occasions he observed both _____ and _____ nude and masturbating. He also stated that at one point he was sleeping and _____ and _____ went into his pants and pulled out his penis and played with it, and he only knew this because he woke up when they were putting his penis back into his pants. When _____ asked Merritt if they sucked his penis he replied "if they did it was when I was asleep". In another comment he stated that all four of the girls would routinely watch his pornographic movies without his permission.</p> <p>On 07/26/2010, I conducted a second follow up consensual recorded telephone call between _____ and Merritt whereas Merritt states that he did in fact receive oral sex from several of these girls. Merritt claimed that these acts were occurring over a period of time which included his residency at _____ in Boynton Beach. Merritt said that the victims also have seen him ejaculate, but he couldn't remember if he got any of the semen on the girls. Merritt stated that _____ also used to ask him to rub against her and he even referenced a time where _____ got into bed with him and took his hand and put it in her private area. It should be noted that the time period that Merritt refers to was approximately five years ago, which made all of the victims children under the age of TWELVE. It would also be important to reiterate that Merritt is now twenty nine years old and was clearly and adult over the age of EIGHTEEN when these acts were committed.</p> <p>On 07/27/2010, I attended CPT Interviews for _____ and _____ was interviewed first and spoke of numerous incidents where Merritt told her to get on top of him while she was nude and he would push his privates into her privates and that "it hurted". She stated that Merritt put his privates into her mouth and ejaculated, and then told her to go and wash out her mouth. She spoke of how these incidents stopped when she was either ten or eleven years old. _____ was interviewed second and stated that Merritt used to make her watch nasty videos and would put his privates in her mouth and ejaculate. Specifically commenting that she had to suck him until stuff came out in her mouth. She also spoke of Merritt putting his below part into her below part and that it hurt. She remarked that this last happened when she was approximately six years old.</p>

She remembered that he [REDACTED] had to suck his penis first and then [REDACTED] had to continue. [REDACTED] also commented that she remembered Merritt "digging in her butt" but didn't go into further detail.
