 On the 04 day of May 20 10 at 1525  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

On 04/29/2010 at 1305hrs, Ofc Kimball responded to 1021 South Federal Highway, Boynton Beach, Florida (Palm Beach County) (Boynton Senior Center) in reference to a delayed stolen auto. On arrival Officer Kimball met with VICTIM W/M Richert, William who stated that three black females all in shorts and two with long black hair, light colored shirts and one with a hair net and multi colored shirt all approx. 5'00 to 5'03 came into the center and obtained the keys to his vehicle and took it without his permission. Richert stated that when he came to the center today at 1229hrs he set his car keys down on a table, in the front lobby, while he played pool.

William believed that the three b/f's had obtained his keys and stole his vehicle a White 2005 4Dr Hyundai Sonata bearing Fl Tag (Y7EKR) Vin # KMHWF25SX5A143873 as it sat legally in the parking lot.


The video surveillance at the senior center showed the three suspects enter the facility, talk with the patrons and then walk outside to search for the vehicle. The surveillance video has an automatic scanning mode which showed the three b/f's walking towards the victim's car then the vehicle is seen leaving the parking lot.


The vehicle was entered into FCIC/NCIC as a stolen vehicle.

On 05-04-2010 at 0118 hrs, a local bolo for the above three black female suspects which included the stolen vehicle information had been sent to all local surrounding police agencies.

On 05-04-2010 at 1525 hrs, Lt Coleman of the Delray Beach Police Department saw the bolo sent by our department. Lt. Coleman was off-duty and shopping at BJ Warehouse 1540 west Boynton Beach Blvd, Boynton Beach, Florida when he observed 3 black females running from BJ carrying unknown items. The 3 females were then seen entering a white 4-dr Hyundai Sonata bearing Florida tag E70-6HT (not assigned). According to Lt. Coleman the individuals seen running from BJ and the vehicle they entered were similar to the Police Bolo sent by our agencies listing the vehicle as stolen.

On the 04 day of May 20 10 at 1525  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

The Boynton Beach Police was immediately notified of the 3 individuals and the vehicle they entered of possibly being the suspects in our police bolo. The stolen vehicle began traveling eastbound on Boynton Beach Blvd. Detective Zampini and Detective Martinez while nearing I-95 and Boynton Beach Blvd in an unmarked police vehicle saw the above vehicle being driven by a black female later identified as B/F TASHA NICOLE THOMAS (03-10-1985). Det. Zampini conducted an investigative traffic stop of the vehicle near the 400 NW 3RD St, Boynton Beach, Florida. Detective Martinez stated the driver of the above vehicle identified as B/F TASHA NICOLE THOMAS (03-10-1985) made a spontaneous statement saying "she knew she was in trouble because the car she was operating was a stolen car".

A VIN verification on scene revealed the vehicle to be a stolen vehicle from our city and the same vehicle in the local bolo sent by our agency.

Sitting in the passenger seat of the same vehicle was a female identified as B/F TIFFANY LAPORSHA JACKSON (05-30-1990). Also in the vehicle were B/F SHAQUITA DUNSON (03-15-1995), B/F TAKESHIA RHYMING (10/12/1992) and B/F ASHLEY HAYWOOD (01-30-1991). These 3 individuals were later released. All of the above individuals were transported to the Boynton Beach Police Department.

While at the police station B/F TASHA NICOLE THOMAS (03-10-1985) made a spontaneous statement saying she was present at the senior center on 04/29/2010 when the victim's vehicle was taken but said she did not steal the victim's keys. THOMAS then refused to cooperate any further in this investigation.

B/F TIFFANY LAPORSHA JACKSON (05-30-1990) also refused to cooperate with the above investigation. My investigation revealed that B/F TASHA NICOLE THOMAS (03-10-1985) and B/F TIFFANY LAPORSHA JACKSON (05-30-1990) were 2 of the 3 suspect involved in the theft of the victims vehicle on 04/29/2010

With Lt. Coleman observation and Detective Zampini and Detective Martinez traffic investigation placing B/F TASHA NICOLE THOMAS (03-10-1985) as the driver of the stolen vehicle and the spontaneous made by THOMAS.

I have probable cause to charge B/F TASHA NICOLE THOMAS (03-10-1985) with Grand Theft Auto F.S.S 812.014 (6) 3rd degree Felony. Thomas was arrested, proccsed and tot Palm Beach County Jail.
