

I was called out for a suspicious head injury to an 11 week old female at Delray Trauma Center that originated from a call in Boynton Beach. I responded to the hospital along with Det Sgt Wallace and met with medical staff as well as DCF once they were contacted. It was learned that B/M Jean-Carlo Baptist had called BBFD (911) because his 11 week old daughter had fallen out of bed and suffered a head injury. The child was taken to Bethesda Hospital but soon transported to Delray Trauma center due the severity of her head injury. I met with the family and DCF at Delray Hospital and learned that Jean-Carlo Baptist was home alone with the child while his wife was at work at Walgreens. The injuries to the child's face and head were not consistent with the story given by Jean-Carlo so I asked him to come to BBPD with me and explain the days events. Once there he was advised of his miranda rights and gave a taped / sworn statement to myself and Det Sgt Wallace. Jean-Carlo Baptist advised that he was tired after working his night job and lost his temper when his 11 week old daughter, _____ would not stop crying. While she was laying in bed crying he told us he hit her with his open hands on both sides of her face, approx 6 to 8 times. This caused _____ to briefly lose consciousness and vomit. Once Jean-Carlo had realized that _____ was not responding normally from the head injury he just caused, he contacted paramedics and had his daughter taken to the hospital for treatment, however told medical personal and paramedics that she fell out of bed and must have hurt herself that way.

Jean-Carlo Baptist was charged with one count of felony Agg Child Abuse and taken to PBCJ. The child remains in the care of the Delray Hospital as the extent of her head injuries are not yet fully known.
