while conducting an investigation of a series of auto burglaries committed in the Briny Breezes Community in which several GPS units were stolen, the Defendant w/m Friedman, Benjamin dob 01-02-89 was developed as a suspect. Friedman's residence is within Briny Breeze. A query of the PBSO pawn database revealed that Friedman had pawned (1) GPS unit on 01-18-10 and (2) GPS units on 01-19-10. The transactions were conducted at the Fasset Cash Pawn store located at 407 S. Federal Highway, City of Boynton Beach, Palm Beach County, FL.

01-27-10 Det. McDevitt and I traveled to Fasset Cash and inspected the three units. Investigation revealed that these units were all stolen during auto burglaries in Briny Breeze. Related BBPD case numbers include 10-004449 and 10-004433. All the burglaries occurred to vehicles with unlocked doors where no forced was used to gain entry.

The three victims from each case arrived with the following results: Reference BBPD case number 10-004449 victim w/f Carter, Lois dob 05-03-38 arrived at the pawn store and POSITIVELY identified the Garmin Nuvi 255w GPS unit s/n 1TV481510 as her property stolen during the burglary. Reference BBPD case number 10-004233 victim w/m Greenwood, John arrived at the pawn store and POSITIVELY identified the Garmin Nuvi 760 GPS unit s/n 17A266418 as his property stolen during the burglary. Reference BBPD case number 10-004433 victim w/m Duncan, Jeffrey arrived at the pawn store and POSITIVELY identified the Garmin Nuvi 760 GPS unit s/n 17A259883 as his property stolen during the burglary.

01-27-10 Friedman is arrested at his home. Discovered at his home \_\_\_\_\_ approx. 10 more GPS units in his house. Several of these units have been linked to other burglaries within Briny Breeze; the investigation towards identifying every victim is on ongoing as of this writing. At BBPD during a post Miranda statement Friedman admitted pawning said items \_\_\_\_\_ Friedman admitted participating in several auto burglaries within his neighborhood \_\_\_\_\_

Based upon the following information I find probable cause to charge Friedman with burglary (auto), grand theft, dealing in stolen property, and false verification of ownership (pawn store).

Friedman was processed and later turned over to the Palm Beach County Jail.
