


BBPD Units responded to the 100 block of SW 2nd Ave, Boynton Beach, Fl. 33435, reference to a double homicide.  
Upon arrival Officers discovered two black male's on the south side of the street, both with gunshot wounds to the head. The victims were later identified by Florida driver's license as b/m Stephen Ocean, DOB: 02-14-86, who was located on the street in front of 132 SW 2nd Ave. Ocean was wearing a yellow Polo Shirt, blue jeans, and white sneakers. Ocean had a single gunshot wound that entered the left side of his buttocks and exited his stomach through and through and a single gunshot wound that entered the back of his right hand and lodged in the back of his head. The second victim was identified as b/m Tite Sufra, DOB: 12-27-85, who was located on the street in front of 138 SW 2nd Ave. Sufra was wearing a white T-shirt, tan shorts, and black sneakers. Sufra had a single gunshot wound to the right side temple area that exited the top left of his skull through and through. A third person was present with the two victims during the homicide and managed to flee the scene on foot and notify the police. Witness stated that he was present with both victims on foot and walking the neighborhood preaching the word of god. While in the area of SW 1st Street and SW 2nd Ave, they encountered the defendant standing under a big tree. The Defendant was medium height and build, late teens, big wide nose, wearing a black T- shirt, long blue shorts, black gloves and a black wave cap. Witness stated they preached to this subject for about (15) minutes, when the Defendant received a telephone call. The Defendant told the other party that he was right down the street and told witness, Ocean, and Sufra that he had to go. Witness advised they proceeded to walk east on SW 2nd Ave when they noticed the same subject that they were preaching to heading toward their direction on foot at a fast pace. Witness said that Tite Sufra started to walk toward the Defendant until he got up close to him. At this time witness observed a muzzle flash and saw Sufra fall to the ground. Ocean began to run east on SW 2nd Ave and was shot through the left buttocks, before the shooter walked up to Ocean and violently shot Ocean in the head execution style.



Based on my investigation there is probable cause for Jeriah Woody for two counts of 1st. Degree Murder.


